### **Regulations:**

- November thru February hours of operation will be 9a.m.-1p.m. Central Time. Every 2<sup>nd</sup> and 4<sup>th</sup> Saturday.
  - March thru October hours of operation will be 8am 12 noon, sometimes 1pm, every  $2^{nd}$  and  $4^{th}$  Saturday of the month.
  - There are usually 4 times a year that there is a  $5^{th}$  Saturday in the month. When there is a  $5^{th}$  Saturday this market will be open.
- Vendors will park and unload in designated areas as directed or marked by event personnel.
- Vendors must be set up and be ready for market opening at 9 a.m. or 8am.
- Spaces (10x10) will be rented on a first come first served basis. Market fee of \$15 per space must be paid prior to setup. All spaces/vendors are required to pay the fee of \$15.
- Vendors will supply their own tables, tents, or any other supplies needed for space.

### • Following items are eligible for sale:

Fresh produce, dried fruit and nuts, plants and flowers, honey, fresh baked goods (following the Cottage Law and labeled with a "Made in a cottage food operation that is not subject to Florida's food and safety regulation"), fresh and dried herbs, jams and jellies (Cottage Law) handmade soaps, handmade wares, local arts and crats, photography, and art. (No used items).

- Professional Food Industry businesses are allowed (following all Florida Statues, with proof of insurance and all required state licenses displayed).
- All produce shall meet the requirements of local and State agencies. For commodities sold by weight, legal scales are required and must be approved by the Department of Agriculture and Consumer Services Bureau of Weights and Measures.
- Any and all items outside this list must gain approval from market personnel.
- <u>Signage:</u> Vendors are permitted professionally produced signage within their assigned space. Tastefully handwritten signs are acceptable. Signs must fit within designated vendor space. All display areas must be neat, attractive and professional.
- Clean-up Requirements: Each vendor/grower must be responsible for cleaning their assigned area. Any spillage must be cleaned up immediately. Any trash or refuse discarded or left on market premises, or right of way is the responsibility of the individual vendor to remove from premises. This includes trach and refuse discarded by vendor/grower's customers.
